**PUBLIC HEARING MINUTES**  
**TO CONSIDER PROPOSED RATES FOR THE OPOLE SUBORDINATE SERVICE DISTRICT**

**1. Call to Order:**

- A. On this 9<sup>th</sup> day of December, 2014 the Opole Public Hearing on rates was called to order at 6:30 PM.

**2. Purpose of Meeting:**

- A. Clerk Pesta read the Public Notice into record.
- B. The Affidavit of Posting and Mailing were also entered into the record.
- C. Clerk Pesta stated there were no written or verbal comments received.

**3. Presentation of Proposed Rates:**

- A. Zoning Administrator Bridget Chard presented the Proposed Rates for the Opole Subordinate Service District to the board and residents. She went over the income that came in to support the SSD, the expenses to operate and maintain the system, the testing and the repairs made to the system. There was a minor change to the year-end amount for the service provider. This showed that the reserves for the system are now spent and the rates need to be increased to build them back up again.

- B. *A motion to close the Public Testimony Portion of the Hearing was made by Chairman Fiedler which was seconded by Supervisor Douvier; all in favor; motion carried.*

- A. *A motion to pass Resolution 2014 – 12.09.14-2 to adopt the new monthly rate of \$57.50, a Hook-up Fee Charge of \$7,500.00 and a Monthly Late Fee Charge of \$45.00 beginning January 1, 2015 was made by Supervisor Fiedler which was seconded by Supervisor Friedrich; all in favor, motion carried.*

**6. Move to Close / Recess Public Hearing:**

*A motion to close the Hearing at 7:08 pm was made by Supervisor Douvier which was seconded by Supervisor Friedrich; all in favor, motion carried.*
